# What does the fund invest in?

The fund invests primarily in equity securities (including common shares, preferred shares, and warrants to acquire such securities) of companies throughout the world that are involved in, or that indirectly benefit from, the development, maintenance, servicing, and management of infrastructures. The fund will be diversified geographically and may invest in a range of small- to large-capitalization companies.

# How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

#### **Risk rating**

CIBC Asset Management Inc. has rated the volatility of this fund as  $\ensuremath{\textbf{Medium}}$  .

This rating is based on how much the fund's returns have changed from year to year. It does not tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

# How has the fund performed?

This section tells you how Class O units of the fund have performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

#### YEAR-BY-YEAR RETURNS

This chart shows how Class O units of the fund performed in each of the past 10 calendar years. Class O units dropped in value in 2 of the 10 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



### **BEST AND WORST 3-MONTH RETURNS**

This table shows the best and worst returns for Class O units of the fund in a 3-month period over the past 10 calendar years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### AVERAGE RETURN

The annual compounded return of Class O units of the fund was 8.9% over the past 10 years. If you had invested \$1,000 in the fund 10 years ago, your investment would be worth \$2,345 as at June 30, 2023.

<ul> <li>Investors who:</li> <li>seek exposure to equity securities of global infrastructure companies; and</li> <li>are investing for the long term.</li> </ul>	In general, you will have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan (RRSP) or a Tax-Free Savings Account (TFSA).
	Keep in mind that if you hold your fund in a non-registered plan, fund distributions are included in your taxable income, whether you receive them in cash or have them reinvested.

# How much does it cost?

The fees and expenses - including any commissions - can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As at February 28, 2023, the expenses for Class O units of the fund were 0.10% of its value. This equals \$1.00 for every \$1,000 invested.

Management fee	Class O units are available to investors who have entered into, or whose representative's firm or discretionary manager has entered into, a Class O unit agreement with CIBC Asset Management Inc. The management fee is negotiated with and paid by, or as directed by, Class O unitholders, or representative firms and discretionary managers on behalf of Class O unitholders. Such management fee will not exceed the annual management fee rate for Class F units of the fund (1.25%).		
Short-term trading fee	Up to 2% of the value of units you sell or switch within 30 days of buying them. This fee goes to the fund.		
Switch fee	If you sell units of the fund to buy units of another fund managed by us or our affiliates, you may pay a switch fee oup to 2% of the value of units you switch. This fee goes to your representative's firm.
